Harrison's Tomb is the site for the 2012 Ohio State Time Trial Championships. The course is a rolling to flat 10.2 mile ideal location. Senior category racers will be doing an out and back for 20.4 miles while the Junior and Master categories will be doing 10.2 miles in one direction with no turns to the finish. This is the same course used for the [Cleves Tuesday Night Time Trial Series](#) and the [33k Time Trial Series](#) if you would like to preview the course before race day under race like conditions.

A \$10 late fee will be assessed to all day of event registrations. On-site registration and check in will be at Taylor High School 36 Harrison Ave North Bend, OH 45052 and will be open from 7:00AM until 8:30AM on race day and again from 11:00AM to 12:30PM for the afternoon wave.

**Rules and Regulations:** All USA Cycling Rules and Regulations must be followed and will be enforced. All riders must have a current USA Cycling racing license or a 1 day license. One day license are available at check in and can only be used for cat 5 men, cat 4 women and Juniors. The promoter reserves the right to combine categories based on attendance.

**Results:** All results will be submitted to USA Cycling within 48 hours after the official results are final. Big Dave Sports will be handling start times, posting and submitting all results. Podiums presented day of event.
